term through the grant period may be considered non-compliance and make grantee ineligible for future SHIP program participation.

- 10. It is expected SORHs will collect and retain the Hospital Grant Applications (A Short Form and B Long Form). To ensure program integrity, at any time, HRSA may request the Hospital Grant Applications from a SORH in order to verify the number of hospitals, hospital eligibility, hospital activities, and amount of funding requested.
- 11. As required in the 45 CFR 75, a non-Federal entity must liquidate all obligations incurred under the award not later than 90 days after the end of the funding period (or as specified in a program regulation) to coincide with the submission of the Federal Financial Report (FFR). - 16. Personnel costs are only for the oversight of the award and do not include hospital personnel costs. "Travel," "Equipment," "Supplies," "Construction," and "Other" are not allowable expenses. SORHs are encouraged to limit indirect costs to the lesser of 15 percent of the amount of the grant for administrative expenses or the state's federally negotiated indirect rate for administering the grant.
- 17. The funds for this award are in a sub-account in the Payment Management System (PMS). This type of account allows recipients to specifically identify the individual grant for which they are drawing funds and will assist HRSA in monitoring the award. Access to the PMS account number is provided to individuals at the organization who have permissions established within PMS.
