Online Human Trafficking

The exploitation of people through online, internet-based technologies for the purposes of sexual and labor trafficking.

Number of Child Sexual Abuse Files reviewed by the
National Center for Missing and Exploited Children

2004: 450,000

2019: 70 million files

child victims have been advertised online
